

# Spay/Neuter Contract

In this contract the furnishing of registration papers or the refund option is based on whether the puppy is registered or not. After receiving proof of spay/neuter from a licensed veterinarian a refund of \$ \_\_\_\_\_ will be returned to the buyer or the Seller shall provide Buyer with registration papers at this time. Puppies must be spayed/neutered before their first birthday. Adult dogs must be spayed/neutered within one month from date of purchase. If such proof is not provided within this time, Seller will retain registration papers of puppy/dog or the refund of \$ \_\_\_\_\_ will be forfeited.

It is understood by all parties to this agreement that this puppy/dog of the above specified description, is being adopted as a pet only. Buyer acknowledges and agrees that this puppy/dog will registered by limited registration. In the event that the Buyer does not have the puppy/dog properly spayed/neutered, any offspring are not eligible for registration and can not be registered.

Why should this puppy/dog be spayed/neutered? Any puppy/dog sold as a pet should not be bred. This is simply for the improvement and maintenance of the breeding line. Breeding is not to be done casually nor is it a money making venture. Due to the small stature of toy breeds and problems that can arise with whelping (potential c-section), vet costs can be outrageous, not to mention the risk to the dam. By demanding that this puppy/dog be spayed/neutered it avoids mass production of pets being raised by back yard breeders, controls the dog population and helps keep unwanted puppies/dogs out of Humane Societies and shelters.

IF BUYER IS UNABLE TO KEEP THIS DOG Buyer must agree not to discard puppy at any shelter, Humane Society, or rescue group and will make every attempt to place puppy/dog in a suitable loving home or puppy can be returned to Gan Haven but no refund will be issued. However, in the event that the dog is re-sold, the Seller will forward any monies received to the Buyer minus reasonable care and vet expenses incurred between the time of receipt from the Buyer and re-sale such as getting vaccinations up to date, any vet expenses and advertising to re-home. If return of the dog to the Seller requires shipping, those expenses are the responsibility of the Buyer.

This agreement is made and signed by both parties to ensure the well being and protection of this puppy/dog. If the Buyer breeches this agreement, the Seller is released from any obligation under this agreement to provide registration papers or refund the \$ \_\_\_\_\_ implemented to encourage new owners to have their puppy/dog spayed or neutered.
